Thank you for your interest in Carolina Federal Credit Union's scholarship program. Please read this page carefully. You will be asked to sign your application stating that you have read and understood this information. If you have questions, please contact Carolina Federal Credit Union. To be considered, your application must be signed.

Criteria

Any high school senior who is going into any area of study at a 4 year or technical/community college may apply for a \$1,000 scholarship.

Eligibility Policy

- Selection criteria may include, but are not limited to: GPA, extra-curricular and/or community involvement, career goals, writing skills, and financial need.
- Completed applications and attachments must be received at the Carolina Federal Credit Union office by the close of business, **Friday, April 20, 2018**.
- Please neatly print or type application and attachments.
- All information given on the application must be true.
- Winners of the scholarship will be notified at the Carolina Federal Credit Union Annual Meeting on Wednesday, May 16, 2018. If the student is not present, the student will then be notified by mail.
- In order to receive the proceeds, the applicant must be a full-time student and submit Class Schedule for 1st Semester in school.
- Decisions of the Carolina Federal Credit Union Scholarship committee are final.

Helpful Hints for completing the Carolina Federal Credit Union Scholarship Application

1. Read through all instructions before filling out any forms.
2. Answer all questions. Do not use acronyms.
For example: Use Future Farmers of America instead of FFA.
3. Have someone else proofread your application.
4. Include your transcripts. If your school is sending your transcripts, verify that they have been sent.
5. Have all completed forms, transcripts and teacher references at Carolina Federal Credit Union by end of business day (5:00 p.m.) on **Friday, April 20, 2018**. Mail to: Carolina Federal Credit Union, 1200 E. Church Street, Cherryville, NC 28021. Attention: Scholarship Committee
